- To what extent is this leadership exemplary?

- To what extent has the leadership demonstrated inspiration towards achieving a vision; challenged processes; enabled others to act; and shown encouragement?
- To what extent was this leadership needed? What problem was being addressed through this leadership?

## **2. Key deliverable – difference to primary healthcare (Max marks 25)**

How has this leadership made a difference to primary healthcare in the Murrumbidgee region?

- To what extent has the leadership made a difference to primary healthcare in the Murrumbidgee?
- Was this leadership more than a business-as-usual approach?

## **3. Key deliverable – outcomes (Max marks 25)**

What evidence has been provided to support this application's demonstration of how the leadership in primary healthcare has led to an outstanding contribution to the industry or community?
