.Aim 1: Reduce unplanned presentations to ED and admissions to hospital by people at high risk of hospitalisation during the winter months. during the winter months.;

Aim 2: Improve respiratory hygiene and vaccine uptake, slowing the seasonal epidemic of infectious respiratory conditions.

Description of Activity *

Elevator Pitch: To support the provision of proactive and holistic chronic disease management for patients at risk of deterioration over the winter period, and help to keep people healthier, supported and at home for longer.

Strategy 1: Practice Capability Support

The Winter Strategy model will support general practice teams to improve quality and intensity of care for an identified group of patients that clinicians consider at high risk of becoming unwell or admitted to hospital in the after-hours period during the flu season. This will be done through practice coaching, system improvement and focussed patient support. Additionally, MPHN will utilise LUMOS data to provide insights into the patient journey between primary and acute care.

Outcomes: Improved quality of life for people with Chronic Obstructive Pulmonary Disease and Congestive Heart Failure through improved, proactive, coordinated primary care.

- Reduced avoidable acute care episodes (ED presentations including in the after-hours period and hospital admissions)
- Reduced rates of mortality and morbidity for target cohort

Strategy 2: Marketing CampaignA communications and marketing campaign will be implemented that promotes hand hygiene and flu vaccinations. The advertising campaign will utilise a multimedia approach via TV and social media and posters to educate community.

Outcome: People in the MPHN region are informed resulting in increased vaccinations and reduced incidence of flu and hospitalisation

The WGPAHS clinic is based in Wagga Wagga and operates seven GP clinics per week all in the after-hours period. A second general practitioner is on-call and available via phone and to provide house calls (where it is safe and appropriate to do so) and residential aged care facility visits within the Wagga Wagga city limits.

Children under 17, full-time students, Aboriginal and Torres Strait Islander people and health care card holders are routinely bulk-billed. Improved access for priority populations.

Outcome: Maintain access to after-hours primary care for the residents of Wagga Wagga and visitors.
