Description of Activity *

Elevator Pitch: Facilitate and support evidence-based tailored treatment for young people who use alcohol and other drugs and build capacity of headspace staff to work effectively with these young people.

Describe the activity

MPHN has commissioned specialist AOD treatment providers to provide AOD treatment services into the Wagga and Griffith headspace centres. The commissioned providers employ AOD clinicians to work as part of the team in each headspace centre. The focus of the AOD clinician is two-fold. The AOD clinicians support and supervise headspace case managers and Clinicians in providing brief interventions to young people. The AOD clinicians deliver AOD counselling services to young people who would

benefit from a higher intensity and more specialised intervention.

Outcomes:

Outcome 1: Improvement in health outcomes and a reduction in substance use for young people measured by the outcome tool ATOP, as well as other provider specific outcome measurement tools.

Outcome 2: Increased workforce capacity of headspace staff.
